2023 BOARD OF DIRECTORS NOMINEES

**JULIE PRUETT**

Ms. Julie Pruett spent most of her childhood in the Dallas-Fort Worth area before moving to Burkburnett, Texas, where she graduated from high school. While attending Midwestern State University, Ms. Pruett worked in the retail business before entering the media sales arena in 1987. She transitioned to television from radio, earning several promotions, including KFDX Sales Manager in 1994 and Vice President/General

Manager in 1997, serving 16 years. In 2013, Ms. Pruett accepted the executive role as Senior Vice President/Regional Manager of Nexstar Media Inc., the corporate parent company for KFDX and KJTL. She served in this role until her recent retirement in August 2023. Among other associational affiliations, Ms. Pruett served as Past President of the Texas Association of Broadcasters and on the National Association of Broadcasters Sales and Management Television Committee. Ms. Pruett volunteered on the Union Square Supervisory Committee from 2006 through March 2011, when she was elected to the Board.

There will be no nominations from the floor. The election of officers will not be conducted by ballot when there is only one nominee for each position to be filled. For members wishing to be nominated by petition, the procedures are as follows: Official petitions must be filed with the Secretary of the Board no later than February 17, 2024. Nominees must submit a brief statement of qualifications and biographical data.

**DAVID NIX**

Mr. David Nix, a Burkburnett native, graduated from Baylor University in 1985 with his J.D. degree. He spent time as a prosecutor in the Wichita County District Attorney's office before relocating to work for a law firm in Fort Worth. Then, he returned to Wichita Falls, where he continues specializing in Personal Injury Law at the Nix Law Firm. Mr. Nix served as President of the Wichita Falls Bar Association from 2003-2004 and

remains affiliated with many local and statewide legal associations. He was also a member of the Burkburnett School Board from 1991-1997, serving as President for two years. He has strong ties to the Wichita Falls Summer Basketball League, where he began coaching several teams in the early 80s. Mr. Nix volunteered on the Union Square Supervisory Committee from 2003 until 2006, when he was elected to the Board, serving as Chairman since 2019.
